In VIEW of the importance of Rare Earth Elements (REE), the Government of India will establish a state-of-the-art pilot plant to process 100 kg of Red Mud and extract REE from this aluminium waste. The plant

is expected to be operational by December 2024. Top institutions, including Jawaharlal Nehru Aluminium Research Design and Development Centre (JNARDDC), Nagpur; CSIR Institute of Metal and Materials Technology (CSIR-IMMT), Bhubaneswar; CSIR-National Metallurgical Laboratory (CSIR-NML), Jamshedpur; and National Aluminium Company Ltd (NALCO) have teamed-up to process 100 kg of red mud in the plant which will allow them to optimise REE extraction from waste.
